

EXHIBITORS TERMS & CONDITIONS

By returning this signed application form (“Agreement”), you agree to be a non-exclusive exhibitor of the 09th Congress of the African Society for Blood Transfusion scheduled for 19th to 22nd June 2018 at the Ngurdoto Mountain Lodge’s Tanzania Convention Center (TCC) on the following terms and conditions set out below and as attached to this Agreement.

1. Upon receipt of your signed agreement together with a cheque for the deposit (or a deposit slip for electronic transfers), acknowledgment of receipt will be sent in writing with an Invoice.
2. The amounts payable include items as specified in this agreement and exclude the customization and branding of the stand and other items that are not listed in the exhibition packages.
3. You agree to pay AfSBT the full amount payable and stand shall not be allocated and other entitlements will not commence until the 60% deposit has been paid in full. Deposit is due by 01st December 2017. Full payment is required by 01st March 2018. You understand that stand allocations are done on first come and first served basis by order of received signed Agreement for applicants who have paid the full invoice amount and discreet to the congress secretariat. The AfSBT shall not be responsible for the inconveniences caused including reallocation of the chosen stand due to late payments.
4. Monies paid are non-refundable or transferable.
5. Please note that your requested size of the exhibition space may limit the number of exhibitors and preference shall be based on first in first served basis by order of received signed Agreement and required deposit. The Congress Organisers will notify you if you are unable to acquire your requested exhibition space.
6. Exhibitors are not permitted to enter the congress sessions or social events, unless the relevant tickets are offered as part of the particular exhibition package. However, should exhibitor wish to attend the congress as a delegate (or wish to register additional delegates over and above those offered in the exhibition package) the appropriate registration form must be completed and forwarded to the Conference Organisers together with the applicable registration fee.
7. The Congress Organisers may at their discretion use your logo, symbol, trade mark or registered mark in acknowledging your participation in the congress literature where this is offered as part of your particular exhibition package and no payment shall be made to you for such use. You will be responsible for forwarding your logo, symbol, trade mark or registered mark by the deadline. We request that all logos be supplied in a PDF or jpeg format, high resolution 300 dpi. Should an alternative format be received, the Congress Organisers cannot be held responsible for the quality of the logo displayed in any of the promotional material
8. In return for a hyper link from your company logo on the AfSBT Congress website, you are required to provide a reciprocal link from your website to the AfSBT Congress Website

Nothing contained in this agreement will be deemed to constitute a partnership, joint venture or agency relationship between you AfSBT and/or the Congress Organisers and you must not do anything where you will, in any way, be represented that you are a partner of the AfSBT and/or the Congress Organisers.
