TERMS & CONDITIONS

By returning this signed Sponsorship Agreement (“Agreement”), you agree to be a non-exclusive Sponsor of the 09th Congress of the Africa Society for Blood Transfusion scheduled for 19th to 22nd June 2018 at the Ngurdoto Mountain Lodge’s Tanzania Convention Center (TCC) on the following terms and conditions set out below and as attached to this Agreement.

1. Upon receipt of your signed agreement together with a cheque for the deposit (or a deposit slip for electronic transfers), acknowledgment of receipt will be sent in writing with an Invoice.
2. You agree to pay AfsBT the full amount payable; and Sponsorship entitlements will not commence until the 60% deposit has been paid in full. Deposit is due by 01st December 2017. Full payment is required by 01st March 2018.
3. Monies paid are non-refundable or transferable.
4. Please note that your requested category of sponsorship may have a limit to the number of sponsors as specified in the attached documentation and preference shall be based on first in first served basis by order of received signed Agreement and required deposit. The Congress Organisers will notify you if you are unable to participate in your requested category.
5. Sponsors are not permitted to enter the Conference sessions or social events, unless the relevant tickets are offered as part of the particular sponsorship package. However, should Sponsors wish to attend the Conference as a delegate (or wish to register additional delegates over and above those offered in the sponsorship package) the appropriate registration form must be completed and forwarded to the Conference Organisers together with the applicable registration fee.
